## RULES

**Boundaries:** Fort Gratiot light on the St. Clair River (near Blue Water Bridge) to Ambassador Bridge on Detroit River

**Time:** Saturday, June 6, 2026, 12:01 A.M. until Sunday, June 7, 2026, 1:00 P.M.

**Entries:** One (1) Walleye per person per entry

**Teams:** Teams will be selected by a draw after weigh-in. Three persons per team. Only persons who weigh in fish will be placed on a team.

- *In the event of a tie, the winner will be determined by fish length.*
- *Fish must be in a "fresh-like" condition. Anglers are responsible for the condition of their fish*
- *Fish may be inspected before weighing in. Disqualified fish will not be weighed.*
- *The decision of the judges is final. The G.S.C. fish committee will act as judges.*

## VIOLATIONS

*Anyone violating any of the rules will be disqualified and will forfeit their entry fees. The decision of the Tournament Committee is final.*

## PRIZES

- Smallest Legal Walleye
- Last place team (three-person team), \$25 per person
- Payout: 40% of entry fees for top 3 teams (three-person teams) (50%, 30%, 20%)
