Tournament Rules Summary:

1. Michigan DNR and OMNR fishing rules and regulations apply.
2. Start fishing at **sunrise** – weigh-in closes **3:00 PM sharp**.
3. Anglers must be in line for weigh-in before 3:00 PM.
4. Boundaries: **Tip of Russell Island, LSC, to Ambassador Bridge.**
5. All decisions by tournament officials are final.
6. Fish must be in "fresh like" condition. Anglers are responsible for the condition of their fish. Fish may be inspected before weighing in. Disqualified fish will not be weighed. Decision of the judges is final. The LSCWA fish committee will act as judges.
