

Bob Brethauer and Dave Barc who each rolled a 300 game last year can attest to the fact that everyone had a great time at this event.

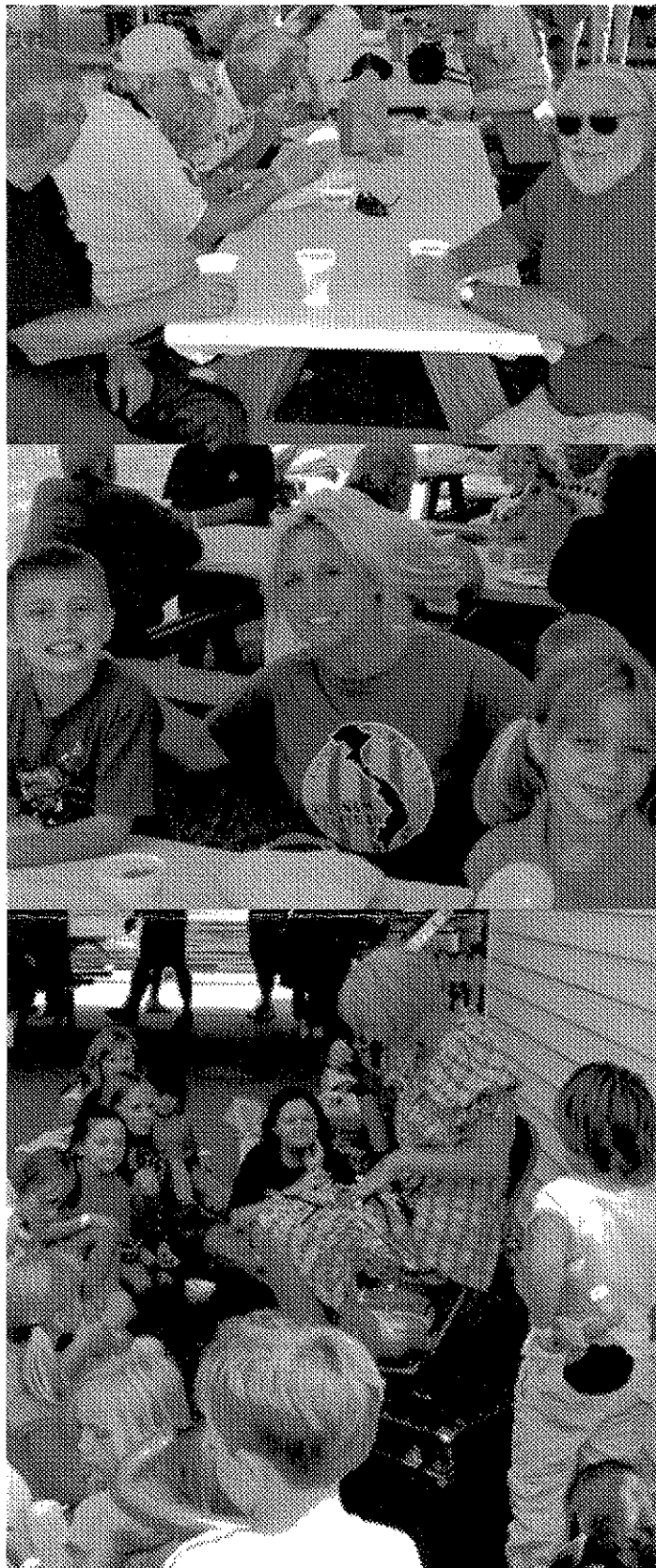
Neither location nor date is yet set. Suggestions welcomed at the September meeting.

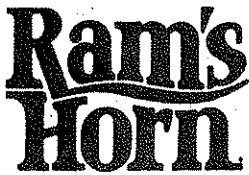

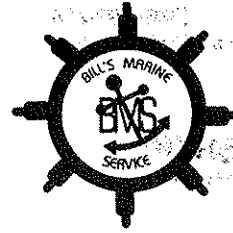
