

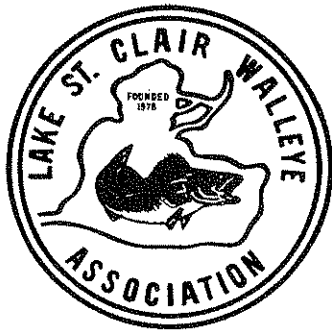

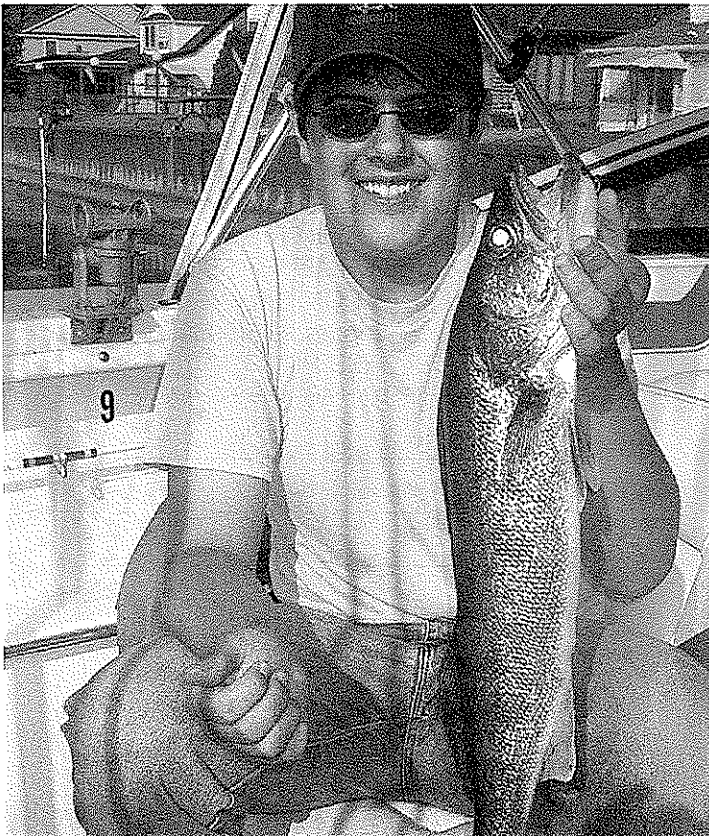

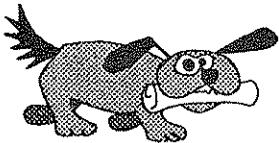

## ASIAN CARP BARRIER BILL MOVES AHEAD

\$9 million needed to keep carp out.

The U.S. House has passed the Water Resources Development Act (WRDA), a bill that contains the provisions to finish construction and maintain the electronic barriers at the mouth of the Chicago Sanitary and Ship Canal. These barriers work to keep the dangerous Asian carp out of the Great Lakes. Asian carp are voracious filter feeders and prolific breeders. Scientists believe that if Asian carp are allowed to enter the Great Lakes, our native fish populations will not be able to compete.

The U.S. Senate is expected to pass WRDA in early September 2007. This is a critical issue for Michigan's sportsmen and women. Keeping these fish out of the Great Lakes is a big step in protecting our valuable sports fishery!

WRDA also contains other provisions that support the Great Lakes:

- Great Lakes Fishery & Ecosystem Restoration Act which provides funding to restore habitat and fisheries.
- Aquatic Ecosystem and Estuary Restoration Program which provides funding to remove dams, improving fish habitat and passage.

## CORMORANT LEGISLATION SIGNED BY GOVERNOR

Although faced with severe declines in the 1960's due to toxic chemicals like DDT, double-crested cormorants have recently experienced a population boom in the Great Lakes. As their numbers have increased, cormorants have caused declines in our fish populations in many areas throughout the Great Lakes due to their aggressive feeding habits. Cormorants also cause ecosystem degradation because of their highly toxic feces and compete with other bird species for nesting habitat. Cormorants are protected by the Federal Migratory Bird Act, but in 2003 the federal government issued a Public Resource Depredation Order allowing certain government agencies to control the cormorant populations in twenty-four states, including Michigan.

In Michigan, the U.S. Department of Agriculture APHIS office is the agency tasked with cormorant controls. APHIS has already seen success in some of their cormorant control programs. One example is the Les Cheneaux Islands near Cedarville, MI. Since cormorant controls have been in place, they have seen a huge resurgence of their perch populations and a resurgence of anglers traveling to that area.

These new bills, which were signed into law on August 2nd, would require the Michigan Department of Natural Resources (DNR) to work along with the federal

agencies to implement a cormorant control program.

HB 4471 (Booher) defines "cormorant damage" as "adverse impacts of double-crested cormorants on fish, including fish hatchery stock, wildlife, plants and their habitats."

HB 4614 (Sheltrown) would create a new "Cormorant Control Fund" within the state treasury that could receive money or assets from any source to help address cormorant damage.

S 654 (McManus) would require the DNR to administer a program to control double-crested cormorants, require the DNR to work in conjunction with other states to address the cormorant problem on a regional scale and help create a "Cormorant Control Fund."

## YOUR NEW PRESIDENT

Because he traveled a lot for business and also owned two other part-time businesses taking up all his time, he had to drop out of the Walleye Association during the 80's.

Dave and his second wife Linda have been married for 26 years. Their six grandchildren (ages 5 to 16) all love to fish. Dave and Linda have lived on Anchor Bay near Cotton Rd. for the past 21-years.

Altogether Dave has spent many days of every month fishing Lake Saint Clair. His fishing partners have been Tony Kozlinski, Dave's two sons David & Bryan, his Golden Retriever 'Sege' and several club members who do not have a boat of their own.

Our new president also has a great deal of experience with formal meetings. Dave was a City of Roseville Planning Commissioner for 3-years. ## RECIPE SECTION

Here is one of two recipes presented by Bobby Flay of the Food Network. He was having a competition with an "English style fish and chips" restaurant in New York. He presented two common side dishes to go with the fish. Naturally, the Tartar Sauce is for the fish.

This recipe made a very tart or bitter tartar sauce and it was thin instead of the usual thick style most of us are familiar with. I felt that this was because of all the lemon juice. The lemon juice was simmered down to only a 1/2 cup. This bitterness will probably be more than most people will find tasty. I know I did not care for it.

But, if you enjoy bitter tastes sometimes found in British cooking then this might be for you. The simmering of the lemon juice, incidentally, took about 2 hours. Leaving the juice on the stove longer might increase the bitterness or tartness a little bit but it should keep the final tartar sauce from being as thin. Another suggestion might be to substitute some other hot pepper for the Habanero which is considered to be one of the hottest peppers available.

### LEMON-HABANERO TARTAR SAUCE:

3 cups lemon juice  
1 1/2 cups prepared mayonnaise  
2 anchovy filets, chopped  
1/2 habanero, chopped  
6 cornichon, finely diced  
2 tablespoons capers  
Salt and freshly ground black pepper

Bring the lemon juice to a boil over high heat in a small saucepan and cook until reduced to 1/2 cup. Let cool.

Combine cooled lemon juice, mayonnaise, anchovy and habanero in a food processor and process until combined. Scrape the mixture into a medium bowl and fold in the cornichon and capers and season with salt and pepper. Cover and refrigerate for at least 1 hour before serving.

### ALL ABOUT CORNICHON

I found and printed up a recipe for the Cornichon listed in the ingredients. I substituted a chopped up "refridgerator dill pickle" but I do not see why some dill pickle relish could not be used.

**CORNICHON:** (from the food network) Definition: [KOR-nih-shohn; kor-nee-SHOHN] French for "gherkin," cornichons are crisp, tart pickles made from tiny gherkin cucumbers. They're a traditional accompaniment to pates as well as smoked meats and fish.

Cornichon-Style Pickles

Cornichons -- French for "gherkins" -- are tart pickles made from tiny gherkin cucumbers. Finding these cucumbers can prove difficult, so we created an equally tasty and petite alternative by slicing the smallest available pickling cucumbers into thin spears. Store in vacuum-sealed Mason jars or packed in glass-topped jars and refrigerated.

Yields: Two 1-pint jars; nutritional information based on a 1/2-cup serving

### INGREDIENTS:

2 pounds small pickling cucumbers, cut into 1/2-inch spears  
1/2 cup kosher salt  
2 cups white distilled vinegar (5% acidity)  
1 clove garlic, halved

1 tablespoon chopped onion  
1/2 tablespoon peppercorns  
2 whole cloves  
2 bay leaves

### DIRECTIONS:

1. Prepare the cucumbers: In a large nonreactive bowl, toss cucumbers with 1/4 cup plus 2 tablespoons salt. Transfer to a cheesecloth-lined colander and let drain for 2 hours. Rinse cucumbers thoroughly with cold water and set aside.

2. Process the pickles: Combine vinegar, 2 cups water, and remaining salt in a small saucepan over high heat and bring to a boil; reduce heat to medium and set aside. Sterilize two 1-pint jars and keep hot. Divide the garlic, onion, peppercorns, cloves, and bay leaves between the jars. Add the cucumbers up to 1/2 inch from the top of each jar. Pour the hot vinegar mixture over the cucumbers, leaving 1/4 inch headspace. Remove any air bubbles, securely cap each jar, and process using the boiling-water canning method for 10 minutes. Cool jars, check for proper seals, and store in a cool, dark place at least 3 weeks before opening. Will keep for up to 1 year. Thoroughly cooled, unprocessed pickles will keep refrigerated for up to 1 month.

## MORE TRADITIONAL TARTAR SAUCE

The following recipes were two of many that were found on the InterNet site call the Recipe Source. These will produce a tartar sauce that is similar to the type that most of us are used to.

### RED LOBSTER TARTAR SAUCE

1/2 c Kraft's mayo  
1/4 c Sweet pickle relish  
2 tb Miracle whip salad dressing  
1 tb Sugar  
1/2 ts Dry minced parsley  
1/4 ts Onion powder

Mix all and stor in the fridge.

### TARTAR SAUCE

2 eggs  
1 Tablespoon capers -- finely chopped  
1/2 Tablespoon pickles -- finely chopped  
1 Tablespoon parsley -- finely chopped  
1 teaspoon mustard  
1 teaspoon lemon juice  
1 tablespoon mayonnaise  
freshly ground white pepper -- to taste

1. Mash yolks from the hard boiled eggs  
2. Stir in rest of ingredients. Taste and correct seasonings. It should have a firm consistency.

NOTES : If you wish you can process 1 of the whites finely and add to the sauce. Don't add any more than that or it will affect the taste of the sauce.

# WHEN THE GOING GETS TOUGH....

...The tough get out their Rabble Rousers. Whoa now! You are asking what is this Rabble Rouser thing?

The new Rabble Rouser is officially called the Pop's New Rabble Rouser. They have been on the market for about 5 years and are available at many of the small "mom and pop" tackle shops here in SE Michigan.

I had heard of them for a couple of years now and just plain was not that interested. That is, until this past spring when I was at the Novi Fishing Show helping out at the club table. During one of the breaks I came across a display of these lures and was impressed with the color schemes and the overall paint job. That night I went home with about 6 of these lures.

It ended up that I forgot about them until mid summer when the Walleye fishing on the upper Detroit River started to slow down in late June and early July. For a week or two I tried all those spoons that had produced fish before and the Rapalas and the "wobblers" and the "spinners" with just moderate success. Then one day a club member, Curt "How-wired" Kratt mentioned the Rabble Rousers he had bought earlier in the year and I suddenly remembered the lures still in the travel tackle bag.

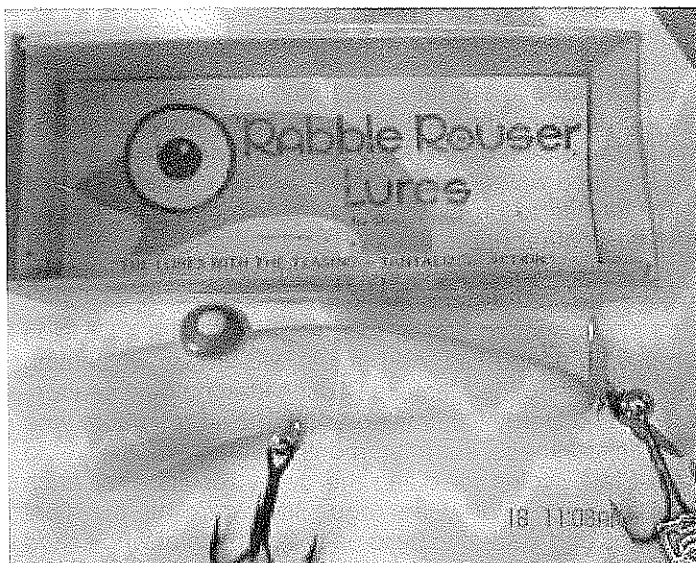
So, the next trip out on the upper river a Rabble Rouser ended up on the end of a leader. The action was great; a steady wiggle without an overly aggressive action to it. To be honest but on that trip no fish hit that particular lure. But, the next day things changed. The lure started being attacked by just sub-legal sized Bass and the Walleye did hit it.

On several trips the majority of the Walleye taken were on a Rabble Rouser. On one trip each Walleye towards a Michigan Detroit River limit came on Rabble Rousers. I had talked to Curt recently and he mentioned that he has taken a limit with his Rabble Rousers in the middle river area down near the "Casino" or "Ambassador Bridge" area.

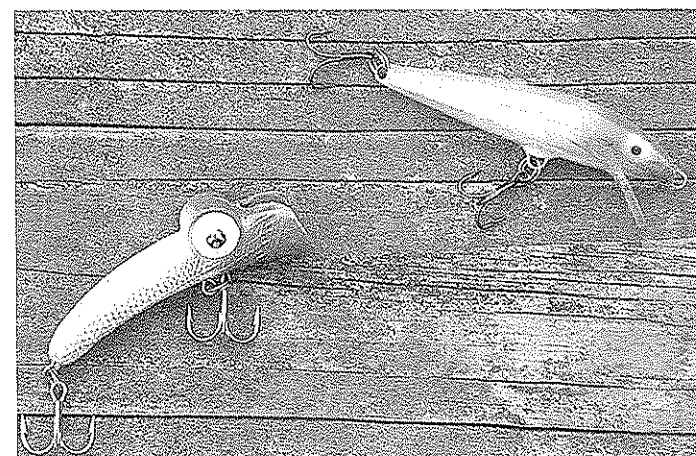
Then, this past August I found out that Bob Barnes took in a large Walleye while fishing for the August Derby. Guess what the lure was. Yep, a Rabble Rouser. In talking to the person who makes and markets this lure I was told that the winning fish in the Algonac Pickeral Tournament a couple of years ago was taken on a Rabble Rouser. Just so that Bob can brag his fish was larger and is still the largest Walleye known to have been caught with one of these lures.

Some notes of interest to the club members are that the current color paint patterns are 46 in both regular paint and in chrome. That sure is a lot of choices. This lure can be fished by all popular methods including wire-lining, pulling bottom bouncers, whipping, rod & reel trolling, and on Dipsey and downrigger set-ups. It is a versatile lure for sure.

The lure can be found at Lakeside Fishing Shop in St. Clair Shores and at Blue Water Bait in Fair Haven. Incidentally, both of these stores are sponsors of our summer derbies. The Rabble Rousers are also sold at Anderson Pro Bait in Port Huron and at Wise True Value Hardware in St. Clair.
