Although the weather was challenging in the morning with heavy downpours and dark clouds, it cleaned up just in time for the start of the event. The weather didn't deter the volunteers from setting up the food and fishing gear for the eager anglers. Over 125 participants came from as close as Chesterfield and from as far away as Holly Michigan to cast a line in this unique event. Each participant received breakfast, lunch, use of fishing equipment, bait, and a door prize. This was all made possible by event founder and coordinator, Louis Caloia, and Shorewood Kiwanis Club, located in St Clair Shores, Michigan. Secretary of Sherwood Kiwanis Club, Colin Casey works with event director Louis throughout the year, on the many behind the scenes details of the event. Other organizations that support the event where; the Alhambra; Knights of Columbus; Meijer's United Food and Commercial workers Local 951



(UFCW); Meijer's - Harper and Little Mack; Kirk Ritchie, LPL Financial; Tom Peck, State Farm Insurance; Shorewood Kiwanis; Lake St. Clair Walleye Association (LSCWA); Macomb County Sheriffs; Lakeside Bait Shop; Mackie Baits; and Chesterfield Township. It was great seeing fellow club members Dan Schmidt and Tim Schwark that volunteered for the event with myself and Tackle Box Joey.

BOATING SAFETY *by Rich Benson*

May 18th, 2018 will forever be stuck in my mind. It's the day I and two of my fishing partners nearly died from hypothermia on Lake St. Clair. We were pre-fishing for the May Madness event, in rough water with a strong NE wind. Conditions changed drastically in a few minutes time, the wind speed increased, the waves seemed to have gotten big almost instantly. We needed up taking a few waves in succession over the transom, capsizing the boat in about 20 seconds time.

20 seconds....it's taken you longer to read this far already, much less be prepared to ditch in mid-50 degree water, but there we were in 4-5' waves clinging to the side of the capsized hull for our lives. It happened so fast that no distress call was able to be made, no flares grabbed, and unlike the other two fisherman who were wearing automatic inflatable PFD's, I was in the water without a life vest. Only through luck and a waterproof cellphone case was I able to call 911 and get through to help. The rescuers were able to triangulate on my cell signal to locate us. The Canadian Coast Guard responded and after nearly 90 minutes in the water were we rescued. A huge thank you goes out to the members of that Crew who saved us, we were all treated for hypothermia in Windsor or Chatham area hospitals and released.

There is not a day that has went by that I haven't thought about what happened, what could have happened and furthermore, what precautions I can share as I relive and analyze that day.

First, in the type of situation we were in we could not self rescue. There would have been no swimming to shore as we were too far out and the cold water would have taken us before long. You need to be heard and then seen, how you accomplish that can be in many ways. Epirbs are one, when activated they send a distress signal that is picked up and alerts rescue crews to your location. They are available in both manual and automatic operations. Ship to shore radios, while we had a fixed mount with 4' antenna, we were unable to get to it fast enough to send a mayday. My answer is a handheld VHF radio, I recently upgraded to a GPS transceiver radio. When I make a call, my location is now instantly sent with every transmission to radios equally equipped. Take in mind a few things, the range on a handheld is limited, especially in receiving incoming transmissions....that being said, your transmissions may be heard further away than you can receive from as well. Floatation/waterproof....some radios will only float with their rechargeable battery packs in them, if you're using disposable batteries they may be too heavy to float, check specs before you buy. Cell phones, here's a tricky one. Some areas of the lakes we fish may or may not have cell service, or your provider may not have coverage or you may not have access to roaming enabled. Luckily, I had not only a waterproof case, but international calling. Check your own personal plans. The last part about being heard is about horns and whistles. Handheld horns are recommended not only because they are portable, but also as a backup in case of electrical malfunctions. Whistles are good to attach life vests as an aid to locating you in low light or nighttime conditions when help is nearby.

Being seen is next, in a situation like we were in, we only had the pitching of the seas throwing the boat up and down as an aid to the rescuers in finding us. Visual distress signals such as aerial flares, hand held or the automatic electrical flare would have been extremely helpful. Smoke flares are for daytime use only, but in the conditions we faced in strong wind, they would have been dispersed immediately....and they are recommended only when help has been seen as an aid to locating you. Mirrors to signal search helicopters or planes are also available. In most flare kits there is also a large orange distress flag, deploying it may be done by using a boat antenna, fishing pole, mast etc. Now here's something that some of you might laugh at, but I actually know of a case on Lake Huron where swim noodles saved lives. Yes, those cheap foam swim noodles for use in swimming pools by kids can actually save lives. How? Instant floatation aid, a reach stick, hold above your head for an easy distress signal (brightly colored I suggest)...many uses can be imagined. Personal lights and or beacons on life jackets are also a wise addition, they are available in manual and automatically activated as well.

PFD's.....I am lucky to be here still, if your PFD is within arms reach it is still useless, they should always be worn. Comfortable and in good shape are not only recommended, but in my eyes should be mandatory. The big orange uncomfortable ones are in my opinion a poor choice. Not only will they discourage wear, they make mobility in the water a bit more difficult than a properly fitting vest. Throwables are required on boats and they should be instantly accessible, which is the next bit that I'm going to touch on.

Accessibility, if you cannot access these items, you cannot use them. In our situation we had a radio, we had flares, we had extra PFD's in addition to the one I wasn't wearing, we just had no time to get to any of those items. Which is why I have purchased a rapid ditch bag. I now have a floating rapid ditch bag containing extra visual distress aids, first aid, lights and tethers to tie not only the bag down, but also to tether other members of the crew together in a survival situation. These items are in addition to the required safety items on my boats, they are now immediately portable and will be stored near the bow outside of any compartments so they can be accessed in an emergency including a capsizing. If you are involved in something like this, DO NOT LEAVE THE BOAT HULL as long as it floats.

In closing, I acknowledge I made a huge error in not wearing my PFD, but through luck and keeping a bit of calm in our situation, we are here to share with you some of the things we have learned. Please, review your own gear and emergency preparedness plans before you hit the water next.

POND UPDATE *By Jim Lease*

Another year of raising walleye has come and gone. In June the DNR came and extracted this years walleye harvest which was a little disappointing. In past years you might remember that if the DNR is able to remove half of the fry they placed in the ponds in April they consider that a good harvest. As in past years they placed 300,000 fry this year; 150,000 in each of our two ponds. This year the south pond did not produce well at all. A low figure of 5,913 fish. 2.2" average size. were removed and transported to Big Lake in Oakland County.

Out of the north pond, which is the one we had trouble with losing water, the DNR removed a more respectable 57,858 fish at an average length of 1.6" in size. The following lakes received fish.

White Lake in Oakland county33,928

Stoney Creek Impoundment in Macomb county23,930

We put on a great fish fry as in past years. We served 142 people on a warm but mostly sunny day. I was very lucky to have had as much help this year as in any previous year. Eighteen helpers showed up including Larry Adamek and Calvin Sherwood who did the cooking. These two guys come out every year and manage the cooking, moving fryers, get out the supplies and clean up the grills at the end. Without these two guys. I don't know what I would do. Joann and Richard Koch more or less run things at the ponds. Joann gets all the fixings out and on the tables for our guests and that is after her and Richard haul most of the supplies up to the base. They help me buy the groceries and make this lunch happen. Bob Barnes, Richard Okerhjelm, Charles Henderson, Dan Schmidt, Dale Billings, Gary Rowoldt, Eugene Ramin and his wife Judi and Jim Gimpert were there for the whole event. Setting up tents, doing all the heavy lifting and taking care of the numerous small details is no small feat. Jerry Comfort helped set up and then sold motor raffle tickets for the event.

Don Murray is always there when you need him doing whatever is asked of him with no complaints. Richard Benson (no not the Prez) loaded up and drove the trailer out and returned it to storage. Sarah McNichol was no help at all. Just kidding, she helped the DNR harvest the fish. The DNR guys told me she was a great help and would welcome her back any day. All the people mentioned are members who through their hard work the event would not be possible. Thank You all for your support and fine job. If I forgot to mention anyone's name who came out, my sincere apologies.


